EXECUTIVE SUMMARY

In September 2018, the California Legislature passed Senate Bill (SB) 1348, which requires the California Community College Chancellor's Office (Chancellor's Office) to report additional information about clinical placements at degree and certificate programs in allied health. The reporting requirements began with seven programs in 2019-2020, affecting 134 individual programs at 80 individual community colleges across the state. Nine additional programs were added to the reporting requirement in 2020-2021, with all remaining allied health programs included in 2021-2022.

The new reporting requirements mandate the collection of the following information: 1) identifying data on healthcare providers that host students, 2) how many students are hosted at each site, and 3) what languages those students are proficient in other than English. These languages include American Sign Language (ASL), Amharic, Arabic, Armenian, Bulgarian, Chinese, Farsi, French, Guarani, Hindi, Hmong, Italian, Korean, Krahn, Lebanese, Luganda, Malay, Pangalatok, Portuguese, Punjabi, Russian, Samoan, Spanish, Swahili, Tagalog, Tigrinya, Turkish, Ukrainian, Uzbek, Vietnamese and Other.

The project raised awareness and provided insight into the field's existing data collection processes. Results from interviews, focus groups and a survey revealed that while some required data was currently collected, new practices would need to be adopted at most campuses to support compliance. In particular, new data is required to describe formally identifiable information for medical facilities, and student language proficiency would need to be collected for the first time at most campuses. Additionally, colleges may also consider the integration of available technical systems to their collection processes.

To facilitate <u>SB 1348</u> compliance within the California Community Colleges, an advisory group was assembled in 2019-2020 with leaders drawn from the seven programs impacted. This advisory group recommended the development of a stand-alone web portal to facilitate data collection and reporting compliance. After two years of collecting data in a stand-alone portal, it was determined to be more efficient to incorporate the data collection tool as a module within the Chancellor's Office NOVA system. The NOVA system is used for many reporting processes and routine interactions with the Chancellor's Office. Therefore, NOVA is familiar to a large number of individuals who are tasked with providing the data in compliance with <u>SB 1348</u>. For the 2021-2022 reporting year, the <u>SB 1348</u> data was collected through NOVA.

SENATE BILL 1348 – BACKGROUND

SB 1348 was signed into law in September 2018. It introduced new reporting requirements focused on generating data about clinical placements for educational providers that offer degree or certificate programs across the allied health professions in California. The statute reflects the division in oversight between California's public and private universities: Section 1 of the new law targets community colleges in the state regulated by the California Department of Education, and Section 2 targets private institutions regulated by the

California Bureau for Private Postsecondary Education within the California Department of Consumer Affairs. While the requirements in the two sections are similar in their overall objective, the reporting requirements for California Community Colleges covered in Section 1 are significantly less comprehensive than those required of private institutions covered in Section 2. As the Chancellor's Office is issuing this report, the report will focus exclusively on impacts <u>SB 1348</u> will have on California Community Colleges, as defined in Section 1.

REPORTING REQUIREMENTS FOR CALIFORNIA COMMUNITY COLLEGES INTRODUCED BY SB1348

<u>SB 1348</u> requires that the Chancellor's Office report data describing the number of students receiving clinical training at individual clinical sites on an annual basis. For purposes of standardization, specific requirements about how to identify the clinical sites are included in the legislation. The data collection requirements are as follows:

- 1. Counts of clinical trainees by site
 - 1.1. "The number of students participating at each clinical training site."
 - 1.1.1. "This shall include information about proficiency in languages other than English."
- 2. Identifying information about clinical sites
 - 2.1. "License number of each clinical site."
 - 2.1.1. "If the license number is not available, the report shall include the employer identification number of the clinical training site."

SB 1348 (Section 1, "c") mandates that all disclosures be done in compliance with all applicable state and federal privacy laws. As presented above, collection of the data required for compliance does not require links to individual identifiers and can be accomplished without triggering additional data security and privacy measures.

PHASING IN SENATE BILL 1348

SB 1348 has been implemented over three academic years. The first phase began in 2019-2020 with a subset of allied health programs. By 2021-2022, standardized information was collected from all allied health degree and certificate programs offered by the California Community Colleges. Program reporting will be required every year thereafter. This phased approach allowed the Chancellor's Office and individual schools to scale up the required infrastructure over a period of three years. The table below summarizes

Significant variability exists across the first seven allied health programs analyzed during the 2019-2020 academic year. This variability pertained to the number of programs, program size, program standardization, and professional certification. As a result, the creation of a system that can accommodate the reporting requirements of the first seven programs has been determined to serve other allied health professions effectively.

With the phased structure of <u>SB 1348</u>, a significant number of programs at most California community colleges are required to report data in the current year. The table below summarizes the scale of the reporting requirement as given by number of programs, colleges, and students implicated by the reporting requirements between 2019 and 2022.

This report will detail the data collected for 44 allied health occupational programs, with each program reported using a unique <u>Taxonomy of Programs (TOP) Code</u>. These occupations represent a broad variety of skill levels, educational attainment, and economic achievement. The programs included in this report have at least one educational program, or have students enrolled in credit courses at a California Community College. A total of 67 California Community Colleges have submitted data that is included in this report.

The occupations included in this report are listed in the following table along with their educational program name and TOP and <u>Standard Occupational Classification (SOC)</u> codes.

Substance abuse and behavioral disorder counselors are paraprofessionals who advise people who suffer from alcoholism, drug addiction, eating disorders, or other behavioral problems. They provide treatment and support to help the client recover from addiction or modify problem behaviors.

Alcohol and Controlled Substances represents 40 programs in the California Community Colleges.* In the most recent year, 7,813 students were enrolled in credit courses related to this occupation. ** Programs reported 49 clinical placements for students in these programs. Among the clinical placements, no languages other than English were spoken.

Among allied health programs described in this report, Alcohol and Controlled Substances is in the top 5 in terms of number of programs, and number of students. Median annual wages in California are \$55,000 and program completers have an average income of \$31,000.

Nursing assistants provide basic care or support under the direction of onsite licensed nursing staff. Nursing assistants perform duties such as monitoring health status and assist with activities of daily living such as feeding, bathing, dressing, grooming, toileting, or ambulation.

Certified Nurse Assistant (CNA) represents 22 programs in the California Community Colleges.* In the most recent year, 3,174 students were enrolled in credit courses related to this occupation. ** Programs reported 1,195 clinical placements for students in these programs. Among the clinical placements, the following languages were spoken: Chinese, Farsi, Spanish, Tagalog, and other.

Allied health programs described in this report, CNA is in the top 5 in terms of number of clinical placements, and annual and 5-year job growth. Median annual wages in California are \$37,000. Certified Nurse Assistant median annual wages in California are \$37,000 and program completers have an average income of \$28,000.

School Health Clerk represents 0 programs in the California Community Colleges.* In the most recent year, 52 students were enrolled in credit courses related to this occupation.** Programs reported 0 clinical placements for students in these programs.

School Health Clerk median annual wages in California are \$37,000 and average income of program completers is not available.

Principles and procedures used to assist in the diagnosis, treatment, and prevention of hearing and speech disorders under the supervision of a licensed speech-language pathologist or audiologist.

Speech Language Pathology and Audiology represents 8 programs in the California Community Colleges.* In the most recent year, 899 students were enrolled in credit courses related to this occupation.** Programs reported 84 clinical placements for students in these programs. Among the clinical placements, no languages other than English were spoken.

Speech Language Pathology and Audiology median annual wages in California are \$94,000 and program completers have an average income of \$30,000.

The table below lists each clinical site reported, their license number or EIN (as available), the total number of students at the clinical placement site for the 2021-22 program year, and information about proficiency in languages other than English.

OCCUPATION TITLE: SURGICAL TECHNOLOGISTS

PROGRAM NAME: SURGICAL TECHNICIAN

SOC Code - 29-2055

TOP Code - 1217.00

Surgical technologists assist in surgical operations, under the supervision of surgeons, registered nurses, or other surgical personnel. May help set up operating room, prepare and transport patients for surgery, adjust lights and equipment, pass instruments and other supplies to surgeons and surgeons' assistants, hold retractors, cut sutures, and help count sponges, needles, supplies, and instruments.

Surgical Technician represents 3 programs in the California Community Colleges.* In the most recent year, 91 students were enrolled in credit courses related to this occupation.** Programs reported 0 clinical placements for students in these programs.

Surgical Technician median annual wages in California are \$63,000 and program completers have an average income of \$52,000.

SUMMARY AND ANALYSIS

During the 2021-2022 reporting period, the crisis of the COVID pandemic had receded and clinical placements were slowly returning to a new state of post-pandemic normalcy. Data collected for this report reflects 44 allied health occupation programs from 67 California Community Colleges. 1,745 clinical placements were reported with 7,804 students, which averages ~4.5 students per placement. Of these 1,745 placements, only 31 (1.8%) reported languages spoken other than English. The languages reported included Arabic (2), Chinese (6), Farsi (5), Russian (3), Spanish (18), Tagalog (5), and other (16). Virtually all the instruction in allied health programs in the California Community Colleges is conducted in English. Data regarding languages spoken other than English that may not be available to the reporting institutions.

Some additional insights can be gleaned from further analysis of data concerning the allied health programs. The top 5 programs in terms of number of programs and number of students enrolled in credit classes are General Health Occupations, Emergency Medical Services, Medical Assistant, Human Services, and Alcohol and Controlled Substances. The average completer wages for these programs are \$31,000 with a CA median wage of \$44,000. While these particular allied health occupations represent a large number of employees and projected annual growth, they are not high-quality occupations in terms of economic opportunity. The exception is Alcohol and Controlled Substances which has the highest CA median wages in this group at \$55,000. This represents a living wage in all but the counties of Marin, San Francisco, San Mateo, and Santa Clara.¹ There are a significant number of California Community College programs in these occupational areas. It might be beneficial to focus growth on other programs which benefit completers economically.

There are a number of higher wage occupations that have fewer programs in California Community Colleges. Several allied health occupations which have at least 1 program in the California Community Colleges provide greater economic opportunities based on CA median wages, completer wages, and wage increase. The top programs for these measures are Hospital and Health Care Administration, Dental Hygienist, Diagnostic Medical Sonographer, Speech Language Pathology and Audiology, Radiologic Technology, Polysomnography, Electro-Neurodiagnostic Technology, and Orthopedic Assistant. These occupations have an average CA median wage is \$86,000 and completer wages average \$44,000. 94% of program completers find jobs in the field, and they see a wage increase averaging 51%. These occupations reflect a moderate number of openings and projected growth. The California Community College system should focus on increasing the number of programs such as these that lead more directly to economic self-sufficiency.

African American students are especially well represented in the following programs: Hospital and Health Care Administration, Psychiatric Technician, Dietetic Technician, Community Health Care Worker, and Human Services. Other than Human Services, these programs represent relatively few programs and students, so it's difficult to conclude that these numbers reflect a trend as opposed to a geographic fluke. Hospital and Health Care Administration has the highest median wages among the allied health occupations discussed in this report, in California, and has the highest percentage enrollment of African American students, but there are only 2 programs statewide. Further data and analysis are indicated to identify actionable trends.

The percentage of Hispanic students in the allied health programs ranges from 19 – 60%, with an unweighted mean of 42%. The highest representation of Hispanic students, with at least 56% representation, are in Home Health Aide, Orthopedic Assistant, Dental Assistant, Certified Nurse Assistant, and Speech Language Pathology and Audiology programs. These programs represent a cross-section of allied health program in terms of number of programs and students and economic opportunities. Again, further data and analysis would be needed draw meaningful conclusions.

Of the allied health programs discussed, women represent an average of 72% of students. All programs report greater than 50% women except Emergency Medical Services and Paramedic. The programs with the highest percentage of women, between 89% & 90% are Speech Language Pathology and Audiology, Clinical Medical Assistant, Home Health Aide, Dental Hygienist, and Phlebotomist. These occupations represent some of the highest and lowest median wages in California from among the reported allied health programs. Allied health careers have traditionally been female dominated. Greater gender diversity has been a goal of the workforce planners within the California Community Colleges. While progress is being made, there is room for more gender diversity in most allied health program enrollments.

Economically Disadvantaged students (EDS) are well represented in the allied health programs. The percentage of Economically Disadvantaged students in the allied health programs ranges from 34% – 91%, with an unweighted mean of 80%. Overall, allied health programs represent a good opportunity for EDS students to improve their financial and occupational situation. Allied health programs overall have an unweighted jobs in field rate of 82%. 16 occupations report over 90% employment in the field. This speaks to the direct correlation between educational program and employment. Additionally allied health completers report an average of 31% wage increase, with several programs reporting greater than 50% wage increase.

Two occupations deserve additional attention, Dental Hygienist and Radiologic Technology. These occupations represent among the highest median wages and highest wage increases among allied health programs, greater than 90% jobs in field, and diversity of students. Based on the number of associate degrees and certificates awarded, the California Community Colleges are not meeting the projected annual growth in these occupations. While there are many allied health programs with larger enrollments and more job openings available, these occupations represent greater upward mobility and economic opportunity. Program expansion should take into account the economic success of completers. While increasing enrollments and completions, the California Community Colleges need to continue to focus on quality of opportunities and not just number of openings.

CLOSING SUMMARY

Clinical experience is a fundamental part of each allied health training program. This experience provides the student with the hands-on patient care and guided practice, working side-by-side with professional mentors, needed to fulfill program requirements, accreditation, and develop competency to perform the job trained.

Availability of clinical placements continues to be a limiting factor in allied health education. At this stage, most of this reporting continues to be anecdotal. <u>SB 1348</u> was passed to develop a source of data to support or refute that contention. 2021-2022 is the first year of full implementation of <u>SB 1348</u>, with all allied health programs reporting. It is hoped that the data collected will help to provide meaningful insight and validate the status of clinical placement availability in California.

In the 2021-2022 reporting cycle, California Community College allied health programs entered data into a digital system developed by the California Community College Chancellor's Office (Chancellor's Office). 1748 separate records of allied health clinical placement data were entered in the data collection system by 68 colleges. Out of all the entries, 32 included languages spoken other than English. This data has been detailed regarding each allied health program in this report.
